Porcine Epidemic Diarrhea virus (PEDv) Testing Data from NAHLN Laboratories

Report prepared 12/04/2013

- This report was prepared by USDA APHIS VS NVSL National Animal Health Laboratory Network (NAHLN); the report covers the reporting period of 11/24/2013 through 11/30/2013.
 - Due to the Federal shutdown, the NAHLN report was suspended for the weeks of 9/22/13 through 10/6/13. However, the University
 of Minnesota Diagnostic Laboratory collected and reported PEDv testing data during that timeframe.
 - o This report includes data from that timeframe in order to be as comprehensive as possible.
- Data are updated as new information is received and laboratory and/or field follow-up is conducted. Therefore, data summaries provided in this report may differ from those provided in past reports. Additionally, note that the total number of swine accessions does not necessarily equal the number of farm type/age class totals due to accessions that include pigs from different age classes.
- Veterinary diagnostic laboratories that have reported PEDv testing data to NAHLN include: Iowa State University, Kansas State University, Ohio Department of Agriculture, University of Minnesota, Nebraska Veterinary Diagnostic Center and South Dakota State University.
- Starting the week of 6/16/2013, PEDv testing data was coordinated and reported by USDA NAHLN. Weekly data prior to 6/16/2013 was provided by Iowa State University Diagnostic Laboratory.
- Tables 1-5 summarize data from swine samples only (or accessions / premises with biological samples). Table 6 summarizes data from environmental samples only.
